Dear Colleague,

When IDEA was first authorized the focus was on the rights of a child with a disability to access public education (FAPE). Since that time professionals involved in special education evaluations relied heavily on norm-referenced, standardized tests that documented and categorized specific disabilities. However, when IDEA was reauthorized in 2004, a new focus was established: Access to the general curriculum (for preschoolers – age appropriate activities). Therefore, a new question was added to the evaluation process. “If a disability exists, how is it affecting the child’s ability to participate and progress in age appropriate activities?” This question cannot be answered using the traditional methods of the past.

This packet was created to provide early childhood special education professionals guidance in conducting early childhood evaluations and assessments that are based on best practice and adhere to state and federal requirements. During the development of this packet, input was provided from staff at the Kansas State Department of Education, Student Support Services. Much of the information provided was adapted from the *Kansas Special Education Process Handbook* (July 2001).
